Workforce strategies, like Registered Apprenticeship help ensure a strong and equitable post-pandemic economic recovery by connecting Americans to good quality jobs in priority industry sectors, including critical supply chain industries, and among populations disproportionately affected by the pandemic. Registered Apprenticeship programs enable employers to develop and train their future workforce while offering career seekers affordable paths to obtain secure, quality, high-paying jobs.

#### WHAT IS REGISTERED APPRENTICESHIP?

Registered Apprenticeship is an industry-driven, high-quality career pathway where employers can develop and prepare their future workforce, and individuals can obtain paid work experience, and progressive wage increases, classroom instruction, and a portable, nationally recognized credential. Registered Apprenticeships are industry-vetted and are approved and validated by the U.S. Department of Labor or a State Apprenticeship Agency. 90% of apprentices who complete a Registered Apprenticeship retain employment, with an average annual salary of \$80,000

A Registered Apprenticeship is different from other types of workplace training programs in several ways:

- Industry Led Programs are industry-vetted and approved to ensure alignment with industry standards and that apprentices are trained for highly skilled, high-demand occupations;
- Paid Job Registered Apprenticeships are jobs! Apprentices earn progressive wages as their skills and productivity increase;
- Structured On-the-Job Learning Programs provide structured on-the-job training to prepare for a successful career, which includes instruction from an experienced mentor;
- Supplemental Education Apprentices are provided supplemental classroom education based on the employers' unique training needs to ensure quality and success;
- Diversity Programs are designed to reflect the communities in which they operate through strong non-discrimination, anti-harassment, and recruitment practices to ensure access, equity, and inclusion;
- Quality & Safety Apprentices are afforded worker protections while receiving rigorous training to equip them with the skills they need to succeed and the proper training and supervision they need to be safe; and
- Credentials Apprentices earn a portable, nationally recognized credential within their industry.

The length of a Registered Apprenticeship program can vary depending on the complexity of the occupation, employer, industry, and the type of program.
