### **Summary of program activities:**

This project proposes to expand the registered apprenticeship system with the creation and implementation of a new Licensed Practical Nurse apprenticeship, a Certified Teacher registered apprenticeship program, and a Public Sector information technology apprenticeship to provide a pathway from entry level to mid-level positions in IT. Additionally, support will be provided to quality recognized apprenticeship preparation programs in Washington to build on the capacity to significantly increase registered apprenticeship opportunities for all workers, particularly underrepresented populations.

#### **Subrecipient Roles:**

Subrecipients will assist in developing and implementing new registered apprenticeships, expanding existing registered apprenticeships, and diversifying registered apprenticeships. Sub-recipients will lead and execute their portions of the program design in partnership with L&I. Key deliverables of sub-recipients are approval of new or expanded programs by Washington State Apprenticeship & Training Council. Specifically, subrecipents will do the following.

Washington Education Association (WEA) will create and implement a certified teacher registered apprenticeship program to increase the number of teachers in K-12 public schools with Special Education and other high need endorsements.

OSPI will hire a Data Analyst to identify apprenticeship opportunities and school district partnerships opportunities for the Certified Teachers registered apprenticeship program.

Department of Social Health and Services (DSHS) will create and implement a public sector information technology registered apprenticeship program to provide pathway for entry level workers in the public sector.

Washington Department of Veteran Affairs (WDVA) will create and implement a Licensed Practical Nurse registered apprenticeship program to provide a pathway for Certified Nursing Assistants.
