<u>Purpose</u>: To inform staff that the Office of Management and Budget (OMB) authorized the revision of ETA Form 671 (Program Registration, Section I, and Apprenticeship Agreement, Section II) and to transmit copies of these sections and the Notice of Action issued by OMB.

Background: The goals of the Paperwork Reduction Act (PRA) of 1995 (P.L. 104-13) are to reduce, to the extent practicable and appropriate, the burden on respondents. OA complied with the PRA by seeking comments from the public in a Pre-Clearance Consultation Notice published in the <u>Federal Register</u> on June 30, 2008, before seeking authorization from OMB to revise ETA Form 671, Program Registration, Section I, and Apprenticeship Agreement, Section II. On January 8, 2009, OMB, through the Notice of Action, authorized ETA Form 671, and the utilization of the Registered Apprenticeship Partners Information Data System (RAPIDS) for both Sections.

<u>OMB Approval</u>: OMB's control number for ETA Form 671 is 1205-0223. The newly approved revised sections are effective through January 31, 2012. Persons are not required to respond to this collection of information unless it displays a currently valid OMB control number. Public reporting burden for Section I is estimated to average 10 minutes per response and for Section II, 15 minutes per response. These estimates include the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information.

<u>Action</u>: Staff are to cease using the expired ETA Form 671, Sections I and II with the October 31, 2008, expiration date as soon as they receive the revised ETA Form 671, Sections I and II. The revised version of ETA Form 671 will be available in RAPIDS within the next 45 days. Paper copies are forthcoming.
