**PURPOSE:** To establish Bureau policy and Apprenticeship Information Management System (AIMS) procedures for collecting data on nationally registered programs.

**BACKGROUND:** Over the past few years, the Bureau's ability to provide statistical data on national programs has diminished. Part of this problem is the diverse interpretation of national programs. Circular 82-6 (attached) provides the current procedures for properly identifying and handling all national programs.

To assist in cleaning up the AIMS data, the National Office has assigned SIC codes to identify national programs and other program groupings. These "pseudo" SIC codes, shown in Attachment A, will allow AIMS to provide statistical data on each of these groupings.

**ACTION:** The Regional Offices (field staff) should assign the new pseudo-SIC codes to their current national programs and other programs that may fall within the SIC code groupings. Updates should be completed by COB September 13, 1993. Field staff should henceforth use these codes for the appropriate programs.
